






AFRC Overview FY23 In Review

- Recent MILCON program TOA
 - FY17 22: 41 projs, \$710M (ave \$118M/yr)
 - NDAA adds; \$276M, 12 projs + UMMC & P&D
 - FY23: 4 projs, \$42M (NDAA +\$56M; 4 projs, P&D, CTC, inflations)
 - FY24: TBD...
- Four major weapon system beddowns in progress
 - F-35A @ NAS JRB Fort Worth, TX
 - MH-139 @ Maxwell AFB, AL
 - KC-46A MOB 5 @ March ARB, CA
 - C-130J @ Youngstown ARS, OH
- FSRM program execution
 - FY23: 126 projects, \$114.6M (includes design)
 - 44% above PB; ~1.5% of PRV...had \$61M+ ready, unfunded

Total Recap Investment = 2.7% PRV (includes CM MILCON & FSRM)





Environmental Programs PFOS/PFOA

- Drinking water at all AFRC installations tested and meets EPA health advisory standards (70 ppt)
- Ground water Site Investigations found localized contamination at all AFRC installations
- Remedial Investigation efforts in progress
- Disposal of PFOS/PFOA containing material (i.e. soil, water, etc.) is a concern
 - Method/Cost
 - AF guidance required
 - Watching EPA guidance, potential move to 4ppt
- AF centrally manages PFOS/PFOA at AFCEC


