Otis L. Hicks, Jr., is the Base Civil Engineer of the 78th Civil Engineer Group, 78th Air Base Wing, Robins Air Force Base, Georgia. As host civil engineer, the 78th Civil Engineer Group supports the Warner Robins Air Logistics Center, the 78th Air Base Wing, 116th Air Control Wing, 461st Air Control Wing, Defense Logistics Agency, Headquarters Air Force Reserve, and numerous other hosted units on a 6,935 acre in-

stallation. The 78th Civil Engineer Group is responsible for maintenance of an infrastructure valued at \$2.9 billion.

Mr. Hicks earned a Bachelor of Science degree in Mechanical Engineering Technology from Savannah State College and was commissioned in 1980 as a
