Stormwater Infrastructure BMPs for the Digital Age

Stormwater Best Management Practices (BMPs) are traditionally designed to function as passive systems for the management of urban runoff to meet regulatory criteria which include peak flow rate, runoff volumes, and water quality. Such systems are typically over-designed, and rarely represent optimal solutions. Recent advancements in information technology infrastructure, hardware systems, and software are providing a foundation for a future of digitally connected and dynamically controlled stormwater BMPs. These advancements have allowed engineers to develop more optimal BMP designs resulting in smaller BMP sizes and more efficient use of infrastructure. These advancements include: cheaper hardware and software platforms, advanced remote control technologies, cloud-based computing, readily available digital weather forecast data, etc. The technologies have great potential for new and retrofit green infrastructure applications, and in Department of Defense Facilities where real estate is a premium such as the Robins Air Force Base.



The presentation will focus on: case studies where dynamic real time controls of stormwater BMPs have been implemented for optimized BMP performance. The speakers will discuss the benefits of utilizing real time controls, and the applicability of such systems for different types of BMPs.

Colonel Agustin is a native of Honolulu, Hawaii and entered active duty in 1989 after earning a bachelor of science in civil engineering from Santa Clara University and his commission through the ROTC program at San Jose State University. His experience encompasses installation-level positions and positions at the Office of the Secretary of Defense, Air Staff and major command headquarters. The colonel was the first Joint Base Anacostia-Bolling Air Force Element commander and installation vice commander. He served as a wing vice commander; commanded a mission support group, civil engineer squadron and RED HORSE unit; and deployed in support of operations in Southwest Asia as an air expeditionary group deputy commander. Col Agustin was recently nominated by the President to the Senate for appointment to the rank of brigadier general.
