LEED v4 - a new, sophisticated way of taking projects to the next level. With a built-in suite of tools and resources, LEED v4 was developed with project teams in mind. The hallmark of LEED is its consensus based development process

and continuous improvement. Guided by the market and shaped by stakehold-

er feedback, LEED undergoes a number of public comment periods before the final document is balloted by USGBC's membership.



Understand the major changes from LEED 2009 (version 3) and the new Version Four. Wayne Robertson will go over overall changes to v4, along with changes to credits and new categories. The case studies of two projects certified under 2009 will be highlighted as well to see how they'd fare under the V.4 requirements.
