Civil Engineer Work in Afghanistan

Col Benjamin Wham II, PE, USAF, retired served as the Commander of the US Army Corps of Engineers (USACE) Afghanistan Engineer District, South (AES) from 8 July 2011 to 12 July 2012. The district had responsibility for USACE construction across the entire southern part of Afghanistan to include the Regional



Command South, Regional Command Southwest and Regional Command West Areas of Responsibility (AOR). The total land mass in his AOR is equivalent in square mileage to Mississippi, Alabama and Georgia and included 250+ projects ranging from \$200,000 to \$170,000,000. His total program for planning, design and execution was rough 2 billion dollars.

Col(R) Wham will discuss his observations associated with commanding a combat support unit in a kinetic environment; working with the people of Afghanistan and Afghan Contractors; and the challenges of construction projects with-

in an active combat zone. He is only the second Air Force Officer to command a USACE Engineering District and provides a very unique perspective of joint combat support operations.

In 2008 he began working in logistics and took a position serving as a Flight Chief in the 410th Supply Chain Management Squadron.
