# Biography of the guest speaker Col (Ret) John Mogge, the National SAME **President 2014.** Mr. Mogge will be giving the July presentation.



Col. John W. Mogge, Ph.D., RA, CSIP, F.SAME, USAF (Ret.), is Global Director of Technology, Practice and Design, Environmental Services Business Group, CH2M HILL, and the 2013–2014 President-Elect of the Society of American Military Engineers (SAME).

Col. Mogge joined CH2M HILL in 2001 as Southeast Business Group Manager in the firm's Transportation Business Group following a 27-year career with the

U.S. Air Force. By January 2010, he was named a Senior Vice President with the firm and appointed to his current position as Global Director of Technology, Practice and Design.

Before transitioning to the private sector, Col. Mogge held a number of increasingly demanding positions such as the Air Force Reserve Command Civil Engineer, Robins AFB, Ga., (1999-2001), the Commander and Base Civil Engineer, 78th Civil Engineer Group, Robins AFB, from 1996–1999, the Director of Civil Engineer Programs, HQ U.S. Air Force, The Pentagon (1994-1996), and he also served as Director of Environmental Programs, HQ Air Combat Command, Langley AFB, Va.

An active member of SAME since 1980, Col. Mogge has served on the SAME National Board of Direction as an Elected Director and as the Middle Atlantic Regional Vice President. He also served as Robins Post President; was the 2012 South Atlantic/South Central Regional Conference Program Track Planner and Committee Mentor; and in 1996, served as Co-Chair of the SAME National Conference in Washington, D.C. Col. Mogge was invested into the SAME Academy of Fellows in 1996 and he is currently Chair of the SAME National Energy & Sustainability Committee. He also is a member of the American Institute of Architects.

Col. Mogge graduated with a Bachelor of Science in Architecture from the University of Florida in 1973 and completed his master's degree in Architecture at the University of Florida in 1974. In 2004, he earned a doctorate in Civil and Environmental Engineering from Georgia Tech, with a focus on Sustainable Planning, Design and Construction.
