

# **On-Base Tour: Advanced Metal Finishing Facility**

The Advance Metal Finishing Facility (AMFF) was required to modernize plating techniques, enhance productivity, provide the best available technology and best available pollution control technology, and provide enhanced capability to electroplate aircraft components. This facility will provide Robins AFB with state-of-the-art electroplating processes in flexible modular plating lines that are expandable to meet dynamic aviation industry requirements.



Construction of the AMFF began in June 2008. The ribbon cutting

ceremony was held 14 March 2013 and this facility boasts increased capacity for C-5 and C-17 workload while taking the environment into consideration by minimizing energy consumption, improving air scrubber efficiencies, and recycling 50-90% of its rinse wastewater.

Sergeant Quinn also provides professional technical assistance to the AFR Expeditionary Combat Support-Training Certification Center (ECS-TCC) sites Operations Management instructor to enhance wartime readiness and contingency training activities.

SMSgt Quinn was the 2010 SAME Winner of the Society's Paul R. Smith NCO Medal, was the former Secretary for the Panama City SAME post, and recently completed his Bachelors of Science (BS) Degree in Business Administration from the University of Maryland University College (UMUC).
