A Tour of the HQ AFRC modular facility has been scheduled for 21 March 2012 at 1 PM. The tour will be given by Dale Barlow, Area Engineer for the US Army Corps of Engineers, Savannah District.

Tour: HQ AFRC Modular Facility



Come take a tour of the Headquarters Air Force Reserve Command's temporary administrative facility on March 21st. This 90,000 square foot facility will house the HQ AFRC personnel until their permanent campus can be constructed. The project initially includes funding for construction and demolition of the facility - with five option years to lease the facility and furnishings. It's a design-build project with a duration (for design and construction) of 180 calendar days.

Our tour guide will be Mr. Dale Barlow of the US ACE, Savannah District. In addition to Air Force military construction and Army Reserve projects in and around

Robins, he is responsible for military construction administered by the Moody AFB Resident Office and the Atlanta Resident Office (to include Dobbins ARB and the Gillem Enclave) as well as civil works and Veteran's Administration projects being performed in the metro Atlanta area.

We will be meeting at the Horizons Club around 12:45 and then carpool over to the facility. Tour starts at 1 PM and if you would like to go, please RSVP by March 19th. Send your RSVP to the Post secretary at esther.lee-altman@robins.af.mil.

Post Financial Update

As a non-profit organization, SAME Robins Post gives back to the Base and the surrounding community through the promotion of engineering and educational opportunities, supporting the local military members, and by providing charitable donations to worthwhile causes throughout the year.

The Post receives income through two main sources: one is through a portion of Post dues, which is returned to the Post by SAME National; the other is through local fund-raising efforts. The two fundraisers that the Post sponsors each year are the golf tournaments, one for Earth Day with profits supporting Earth Day events and the Base and the other in October, that help provide needed funding to the Education and Mentoring Fund. This Fund supports two annual \$2,500 college scholarships plus a student campership to one of the SAME Engineering and Construction Summer Camp opportunities.

The Post supports continuing education though assistance with conference attendance and travel expenses that helps support the Post mission. Robins Post also supports deployed service members annually by donating funds to the 116th Unit Advisory Committee. The Post also sponsored both Boy Scout Troop 220 and Cub Scout Pack 220 so they can continue their 55 year mission of serving the youth of the Base. Earth Day awareness activities and the statewide Mathcounts competition for area middle school students are two more areas where SAME pitched in to help make a difference.

Announcements from the Post




