# The Deeds of Houston County Habitat for Humanity

Houston County Habitat for Humanity (HoCo Habitat) became an affiliate of Habitat for Humanity International on October 1, 1991. To date, HoCo Habitat has built 43 homes in Houston County. Presently HoCo Habitat is building homes in the Wellston Villas – Neighborhood Revitalization project south of Watson Blvd. Since 2005 HCHH has raised over \$600,000 to build 15 homes with a goal to raise \$1.2 million contributing to a total of 27 homes. One of Habitat for Humanity's slogan is *"We are not giving a hand out, but a hand up."* This is especially true in these difficult economic times. HoCo Habitat seeks to partner with those groups and individuals who embrace the opportunity to make a difference. A difference in the lives of our partner families as well as a difference in our community.

# Presenter's Bio: Thomas A. Prior, Houston County Habitat for Humanity

Originally from Oregon, Thomas A. Prior served in the Air Force for 30 years retiring as a Colonel in December 2007. During his Air Force career he logged over 6000 hours flying air refueling and worldwide reconnaissance missions. Following his flying adventures, he served on several staffs. As a planner on the Air Mobility Command IG Team he developed the mobility ORI concept for the newly acquired air refueling units. Tom and his family arrived in Warner Robins in 2001 and he became the Team Chief on the Air Force Reserve Command IG Team. After three years and visiting almost every Reserve unit, the



command tapped him to lead the Current Operations Division. Here he led a team supervising the Reserve Command's daily operational flying. In January 2008, following his USAF retirement, Tom became a fundraising volunteer with Habitat and later joined the Habitat Board of Directors. In February 2009, when long-time Houston County Habitat leader John Sillers retired, Tom became the Executive Director.

# SAME Spotlight: Member of the Month



Richard "Ric" Powers is the U.S. Army Corps of Engineers' Area Engineer at Robins AFB out of Savannah District. He has been at Robins since 1987 and is responsible for all MIL-CON construction undertaken at Robins AFB and for construction undertaken by the Moody AFB Resident Office and the Atlanta Resident Office and Dobbins ARB Project Office in Atlanta, who supervise work at Fort Gillem, Camp Merrill and Dobbins ARB.

Ric was born in Ohio, spent time in Kentucky and Tennessee before his family settled in Indiana. He graduated from Rose Hulman (Rose Polytechnic) Institute of Technology, located in Terre Haute, Indiana in 1974, with a degree in civil engineering. He began his meandering with the Corps

in the Louisville District immediately upon graduation.

Ric's desire to be in construction has required him to be mobile and first resulted in his moving to Nashville District to work on the Wolf Creek Dam ICOS 280 ft. deep concrete cutoff wall. From there he transferred to Savannah District's contract administration branch where he worked for two and a half years. From Savannah, Ric transferred to the Corps' Middle East Division, where he worked in field, district, and

division level assignments in Riyadh, Saudi Arabia. He also served two tours in the Sultanate of Oman, the first in Muscat and the second in Thumrait. From Thumrait, he was transferred to Beni Suef, Egypt, as Resident Engineer. He returned to CONUS in 1985 as Resident Engineer, Seymour Johnson AFB, NC.

Ric has been an active member of SAME in that he has served in several officer positions such as president, vice president, treasurer. In the past, he has been Programs Director and became a Designated Fellow in 2004. Ric has been a lifetime member since 1997. In 2006, he received the Robins SAME Post President's Award, which was renamed the Ric Powers Achievement Award that year in honor of his dedication and commitment to SAME.
