# Oil & Gas Sector Reconstruction in Southern Iraq

Iraq reconstruction was divided into several Sectors:

- Security and Justice
- Health and Education
- Water
- Electricity
- Oil and Gas

The goals of the Oil and Gas Sector were to increase oil production to 3 million barrels per day and liquefied petroleum gas (LPG) production from associated gas to 3,000 metric tons per day. The informal briefing will discuss some of the efforts to accomplish these goals.

## **Presenter's Bio:** Robert H. Farrell, PE Acting Director, 78<sup>th</sup> Civil Engineer Group

Mr. Robert H. Farrell is the Deputy Base Civil Engineer of the 78<sup>th</sup> Civil Engineer Group, 78<sup>th</sup> Air Base Wing, Robins Air Force Base, Georgia.
