Programs/Program News:

SAME National:

Mr. Coats is working on the Streamer Report. The report is due 31 January 2023. Mr. Coats will submit a draft to the board members to review prior to final submission.

Robins AFB Post Elections:

Mr. Coats sent out the draft ballot of officers/directors on 13 January 2023. The board discussed the position of Post Treasurer. Mr. Coats has been filling that role and remains on the ballot. There were two members interested in that role, however, neither were local to the Middle Georgia area. The Board appreciates both members' willingness to assist and take on the duties of Post Treasurer, however the Board unanimously agreed that it would be best for that person to be local to the area as that person would be responsible for issuing checks for local events, keeping and using the Post's Debit Card, and being able to meet with the local banking institution. Mr. Coats will involve the two volunteers in upcoming Treasurer duties such as the annual audit but will retain the role of Treasurer. The Board approved the Draft Ballot.
